Laura H. stated there were other candidates that expressed an interest after the cutoff date; she noted the position could be re-opened for a period of time to consider any new interested applicants.

The Senior Team members and the Commissioners weighed in on their opinions. Tom W. posed several considerations to the Board members – including qualifications, salary range, strategic planning and tenure.

Following further discussion, it was decided the consultant services were no longer necessary, as the process is well established. Commissioner Johnson motioned to re-open the CEO position with a stipulated 45 day time limit; the motion was seconded and passed unanimously.

As permitted by RCW 42.30.110, the meeting moved to Executive session at 1:28 p.m. for approximately 10 minutes to discuss a real estate transaction.
